However, meetings can be held at any time if:</i></p> <ol style="list-style-type: none"> <li>1. <i>It is deemed necessary by one or more members of the Board of Commissioners;</i></li> <li>2. <i>There is a written request from one or more members of the Board of Commissioners; and</i></li> <li>3. <i>There are written requests from 1 or more Shareholders who jointly own 1/10 or more of the total shares with voting rights.</i></li> </ol> <p><i>In 2020, the Board of Commissioners conducted 8 internal meetings conducted virtually through Microsoft Teams.
